There is a high probability that you will have some bruises to the wrist, or rub burns (what we called "snake bites" as kids) at the conclusion of this class. The most common form of an attack is from a wrist grab so we will be working on this defense repeatedly during the class. The self-defense taught to you will be without the use of weapons, but we will instruct participants to look for everyday items that could be used to defend ones' self if attacked.

**ASSUMPTION OF RISK**

As a participant in this Circle Out Self Defense class by Rubicon Inc. presented by Jeff Schmatt. I understand all parties are not liable for any injury or illness which may result from participation in this self-defense class. In addition, your use of the facilities as a participant in this self-defense class may involve the risk of injury to you or your minor child, whether caused by your child or someone else may cause it. As such you understand and voluntarily accept this risk and agree that Jeff Schmatt and aforementioned parties are not liable for any injury, including without limitation, personal bodily or mental injury, economic loss or any damage to you, your spouse, unborn child or relatives resulting from negligence or other acts of any one during this class.
